VOTING, BALLOTS AND ANNUAL MEETING

PLEASE MARK YOUR CALENDARS FOR OUR ANNUAL HOA MEETING SCHEDULED FOR MONDAY, NOVEMBER 11, 2024, at 7:00 P.M. AT THE CLUBHOUSE. Please plan to attend and bring the enclosed ballot with you. IF YOU ARE UNABLE TO ATTEND, PLEASE VOTE ON THE **BACK** of the ballot as proxy, sign and send your ballot with a board member or another resident. **MARK YOUR BALLOTS CAREFULLY. IMPORTANT REMINDER:** You can vote by ballot or proxy, but not both. Each unit is entitled to one vote. In order to have an official election, there must be at least 50% of Unit owners voting. Oakleaf has 174 units; therefore, 87 ballots are required to have a quorum. This newsletter includes the 2025 proposed budget for your review. The HOA Board will have its regular monthly meeting on Monday, November 4, 2024 at 2:00 p.m. Any owner who has a question regarding the budget may submit their question to any Board member, preferably in writing, in advance of that meeting. An answer will be provided as soon as possible.
